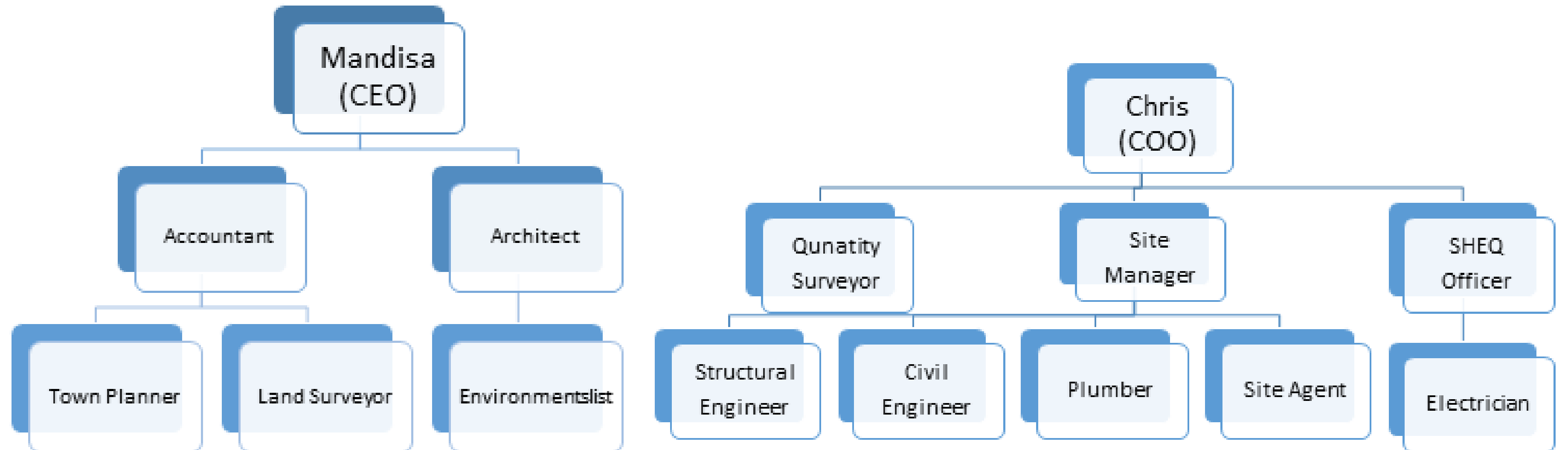


DIRECTORS DUTIES
